(fn. 65) The endowment, not completed until 1404, consisted of land and rent worth 10 marks a year in Walsall, Rushall, Great Barr in Aldridge, Rugeley, Essington in Bushbury, King's Bromley, Finchpath in West Bromwich, Norton Canes, and Stonnall and Little Aston in Shenstone.
